### CALL TO ORDER

Mr. Zeller called the meeting to order at 12:18 PM. Mr. Zeller initiated executive session due to scheduling constraints.

#### **EXECUTIVE SESSION**

Coming out of executive session, Mr. Zeller made a motion to declare the parking at D Lot on Hamilton Street as surplus parking available for sale only in an RFP that puts certain conditions in it including the potential users use of our 940 Linden Deck among other things which will be an ongoing process that we will review and control. Ms. Martinez seconded the motion. The Board voted and the motion passed unanimously.

## **HOTEL TRANSIENT RATES**

Mr. Zeller made a motion for a Board policy that the Board accept valet for 940 Linden Street Deck and Community Deck at full monthly rates of \$125.00 but valet could be used for transients as long as those hotels purchased the software to print their own validating QR codes, software and supplies. In the event that the Board changes its policy for the worst in a 2-year period from the purchase of that equipment the Board will buy back that equipment. This would be available for up to 25 permits per hotel per deck. Mr. Glazier seconded the motion. The Board voted and the motion passed unanimously.
